No.KH/SH/07/PRE/112022/SF-15/K:— In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Special Educator, Class III, in the subordinate service of the Directorate of Primary Education and DistrictPrimary Education Committees or Municipal Primary Education Committees, namely:-

- These rules may be called the Special Educator, Class III, in the subordinate service of the Directorate of Primary Education and District Primary Education Committees or Municipal Primary Education Committees, Recruitment Rules, 2023.
- Appointment to the post of Special Educator, Class III, in the subordinate service of the Directorate of Primary Education and District Primary Education Committees or Municipal Primary Education Committees, shall be made by direct selection.
 - To be eligible for appointment by direct selection to the post mentioned in rule
 a candidate shall -
 - (a) (i) for Special Educator Standard 1 to 5-not be more than 33 years of age:
 - (ii) for Special Educator Standard 6 to 8-not be more than 35 years of age:

Provided further that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (b) (1) for Standard 1 to 5 Special Educator, a candidate shall,
 - (I) have passed Higher Secondary Certificate Examination from the Secondary and/or Higher Secondary Education Board; and

posses:-

- (i) Diploma in Education-Special education obtained from Institution recognised by Rehabilitation council of India; or
- (ii) Diploma in elementary education with recognise qualification (certificate into diploma) equivalent to Diploma in Education- Special education obtained from Institution recognised by Rehabilitation council of India;
- for Standard. 6 to 8 Special Educator, a candidate shall,
 - (i) possess a bachelor's degree obtained from any of the
 Universities established or incorporated by or under the
 Central or a State Act in India; or any other educational
 institute recognised as such or declared to be deemed as a
 University under section 3 of the University Grants
 Commission Act, 1956; or possess an equivalent
 qualification recognised as such by the Government; and
 - (ii) Bachelor of Education in special education obtained from Institution recognised by Rehabilitation council of India;
 or
 - (iii) B.Ed. with recognised qualification (certificate into diploma) equivalent to Bachelor of Education in Special education obtained from Institution recognised by Rehabilitation council of India;

- (c) possess the basic Knowledge of computer application as prescribed in the Services Classification and Recruitment (General) Rules, Gujarat Civil 1967;
 - (d) possess adequate knowledge of Gujarati or Hindi or both; and
 - (e) have passed the Special Educator Eligibility Test as may be prescribed by the Government:
- The provisions of rule 9A of the Gujarat Civil Services Classification and 4. Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct selection.
 - The selected candidate shall be required to get himself registered with the 5. Rehabilitation council of India under the Rehabilitation council of India Act, 1992, at the time of his appointment, if he is not so registered.
 - The candidate appointed by direct selection shall be required to undergo such 6. training and pass such examination as may be prescribed by the Government.
 - The candidate appointed by direct selection shall be required to furnish a 7. security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
